

**REVISED Notice of Public Workshop and  
CEQA Scoping Meeting  
For the Proposed Aquatic Ecosystem Restoration Policy**

**NOTICE IS HEREBY GIVEN** that the North Coast Region Water Quality Control Board (Regional Water Board) will hold two California Environmental Quality Act (CEQA) scoping meetings and workshops on the proposed amendment to add an Aquatic Ecosystem Restoration Policy (Restoration Policy) to the *Water Quality Control Plan for the North Coast Region* (Basin Plan). The first CEQA scoping meeting and workshop (collectively workshop) will be held on November 3, 2011 at the regularly scheduled Regional Water Board meeting in Santa Rosa, CA. The second will be held on November 8, 2011 in Weaverville, CA. The purpose of the workshops is to inform interested parties on the development and scope of the proposed Restoration Policy and to facilitate public comments on potential environmental effects from implementation of a Restoration Policy. A quorum of Regional Water Board members will be present at the November 3, 2011 workshop and may be present at the November 8, 2011 workshop. No action will be taken by the Regional Water Board at these workshops.

**BACKGROUND**

Regional Water Board staff is proposing the development of a Restoration Policy that will serve to demonstrate the continuing support of the Regional Water Board for the use of aquatic ecosystem restoration as one of the existing tools to be used in the restoration and maintenance of the chemical, physical, and biological integrity of the region's waters. As envisioned by staff, the proposed Restoration Policy would articulate eligibility criteria and provide a description of the process for obtaining:

- 1) An exemption from certain discharge prohibitions; and/or
- 2) Authorization for discharges that may cause temporary exceedance of water quality objectives.

**PURPOSE OF CEQA SCOPING**

The purpose of a CEQA scoping meeting is to provide a forum for early public involvement on the development of projects that have the potential to affect the physical environment. In this case the project is the proposed addition of a Restoration Policy to the Basin Plan. Early public involvement assists the Regional Water Board in determining the range of environmental information and potential impacts the proposed Restoration Policy may have on other categories of environmental resources such as air quality or geologic stability.

As directed by CEQA, comments on the CEQA Scoping Document for the Restoration Policy should be limited to identifying the range of actions, alternatives,

mitigation measures, and potential significant environmental effects to be analyzed in-depth as part of the development of the Restoration Policy.

Following the workshops, staff will review written and oral comments and use them to inform the scope and content of the proposed Restoration Policy and supporting staff report.
